SUMMARY -1. Background - During Boeing investigations of a Royal Air Force cracked H-47 rotor blade, and a US Army H-47 rotor blade Quality Deficiency Report (QDR), Boeing found the rotor blade manufacturing process generated distortion in some of the composite material fiber wraps around the rotor blade root end bore. Instead of the root end bore fibers curing in the resin with one smooth and continuous direction, cured fibers sustained wrinkled shaped distortions. Rotor Blade fiber distortion wrinkles preclude the rotor blade from being able to achieve blade fatigue life. 1.2.
